

City of Leoti Governing Body met in regular session Monday, May 7, 2018 at 7:00 p.m., at the City Hall Meeting Room.

Mayor Cheryl Green called the meeting to order at 7:00 p.m.

Mayor Green asked City Clerk Ashley Woods for Role Call; Councilors Kelma Burch, Jody Crouch, Levi Elder, Ken Farr and Charlie Hughes, City Attorney Becky Faurot, City Superintendent Juan Bocanegra and City Clerk Ashley Woods were present.

Farr moved, Burch seconded to approve the agenda with the addition of item d. Executive Session-Non Elected Personnel. Motion carried unanimously.

Crouch moved, Farr seconded to approve the consent agenda. Motion carried unanimously.

Mayor Green presented Ordinance 2018-03 **AN ORDINANCE AMENDING SECTIONS 24-40, 30-208, 30-251, AND 30-352; AND ADDING SECTION 1-4 TO THE CODE OF THE CITY OF LEOTI TO PROVIDE FOR COLLECTION OF DEBTS OWED TO THE CITY.** Crouch moved, Elder seconded to approve as written. Motion carried unanimously.

Mayor Green presented Ordinance 2018-04 **AN ORDINANCE AMENDING SECTIONS 4-25, 4-67: ALLOWING FOR EXPANDED HOURS AND DAYS FOR SALES OF ALCOHOLIC BEVERAGES RETAIL SALES AND CEREAL MALT BEVERAGE RETAIL SALES.** Crouch moved, Hughes seconded to approve as written. Hughes, yay; Crouch, yay; Burch, yay; Elder, yay; Farr, nay; motion carried 4:1 with Farr dissenting.

Farr moved, Elder seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A. 75-4319(b)(1), to discuss a matter involving a city employee for 30 minutes with Council, Mayor and City Attorney. Motion carried unanimously. Meeting resumed at 8:26 p.m. Mayor Green declared no action taken.

Crouch moved, Hughes seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A. 75-4319(b)(1), to discuss a matter involving a city employee for 20 minutes with Council, Mayor and City Attorney. Motion carried unanimously. Meeting resumed at 8:48 p.m. Mayor Green declared no action taken.

Elder moved, Burch seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A. 75-4319(b)(1), to discuss a matter involving a city employee for 5 minutes with Council, Mayor and City Superintendent. Motion carried unanimously. Meeting resumed at 8:55 p.m. Crouch moved, Burch seconded to give the employee discussed a seventy five cent raise. Motion carried unanimously. Crouch moved, Burch seconded to give the other employee discussed a one dollar raise. Motion carried unanimously.

Crouch moved, Burch seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A. 75-4319(b)(1), to discuss a matter involving a city employee for 10 minutes with Council, Mayor and City Superintendent. Motion carried unanimously. Meeting resumed at 9:04 p.m. Mayor Green declared no action taken.

Crouch moved, Burch seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A. 75-4319(b)(1), to discuss a matter involving a city employee for 15 minutes with Council, Mayor, City Clerk and City Attorney. Motion carried unanimously. Meeting resumed at 9:20 p.m. Mayor Green declared no action taken.

Crouch moved, Burch seconded for adjournment at 9:21 p.m. Motion carried unanimously.
