

City of Leoti Governing Body met in regular session Monday, January 21, 2019 at 7:00 p.m., at the City Hall Meeting Room.

Mayor Cheryl Green called the meeting to order at 7:00 p.m.

Mayor Green asked Deputy City Clerk Cendy Morcillo for Role Call; Councilors Charlie Hughes, Jody Crouch, Ken Farr, Kelma Burch, City Attorney Becky Faurot, Interim City Superintendent Joel Landis and Deputy City Clerk Cendy Morcillo. City Clerk Councilor Levi Elder and City Clerk Cassandra King were absent. Also in attendance was Robyn Tokoi.

Burch moved, Hughes seconded to approve the agenda. Motion carried unanimously.

Crouch moved, Farr seconded to approve the consent agenda items A-C. Motion carried unanimously.

Mayor Green welcomed Wichita County Economic Director Robyn Tokoi. Robyn gave council an update on loan procedures, payroll and new employee handbook. An update was also given on various activities and upcoming events.

Council reviewed reports submitted by Interim City Superintendent, Code Enforcement Officer and City Clerk. Landis stated he is strongly encouraging employees to obtain their CDL. Councilor Crouch asked for an update on the jetter currently being worked on at Price Repair. Landis will check the status of the repair and report back.

City Attorney Faurot gave a brief update on the Carpenter easement. She advised council that Laura Lewis will present Ordinance 2019-02 at the upcoming County Commissioner meeting and will report back.

Crouch moved, Burch Seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A 75-4319(b)(1), to discuss a matter involving a city employee for 2 minutes with Mayor, Council, City Attorney and Deputy City Clerk. Motion carried unanimously. Meeting resumed at 8:03. Mayor Green declared no action taken.

Mayor Green opened the floor to public comments. No public comments.

Mayor Green opened the discussion on the Law Enforcement Contract. Farr moved, Crouch seconded to approve the Law Enforcement Contract with changes. Motion carried unanimously.

Crouch moved, Farr seconded to amend Ordinance 2015-09: **AN ORDINANCE REMOVING CHAPTER 12. ARTICLE II, SECTION 12-23 WHICH PROVIDES FOR A HOBBYIST PERMIT FROM THE LEOTI CITY CODE.** Motion carried unanimously.

Crouch moved, Farr seconded to adopt Ordinance 2019-02 **AN ORDINANCE ESTABLISHING APPLICATION PROCEEDURE, FEES, AND TIME LINE FOR APPLICATIONS TO INSTALL WIRELESS FACILITIES IN THE CITY OF LEOTI.** Motion carried unanimously.

Crouch moved, Farr Seconded to recess into executive session pursuant to the nonelected personnel matters exception, K.S.A 75-4319(b)(1), to discuss a matter involving a city employee for 10 minutes with Mayor, Council and City Attorney. Motion carried unanimously. Meeting resumed at 8:29. Mayor Green declared no action taken.

Mayor Green reminded council of the upcoming work session on Thursday, January 31, 2019 at 6:30p.m.

Burch moved, Crouch seconded for adjournment at 8:30 p.m. Motion carried unanimously.
