

City of Leoti Governing Body met in regular session August 2, 2021 at 6:30 p.m., at the City Hall Meeting Room.

Mayor Charlie Hughes called the meeting to order at 6:30 p.m.

Mayor Hughes asked City Clerk Jeannine Hassell for Role Call; Council President Levi Elder, Councilors Kelma Burch, Tammie Meyer-Givens, Tyrrell Tankersley, City Superintendent Travis Seaton, Code Enforcement Officer Adam Marcotte. Greg Graff was present. Councilor Jody Crouch was absent.

Mayor Hughes opened with the Pledge of Allegiance.

Burch moved Givens seconded to approve the agenda. Motion carried unanimously.

Elder moved Tankersley seconded to approve the consent agenda items A-C. Motion carried unanimously.

City Attorney Becky Farout reviewed the Draft of Excessive Noise Ordinance with the council.

Elder moved, Tankersley seconded for the approval of Ordinance 2021-05 Defining Disturbing the Peace and Making it a Violation of the Law. Motion carried unanimously.

Givens moved, Burch seconded for the Approval of 7<sup>th</sup> Street Improvement Project Pay Estimate No. 5 in the amount of \$19,443.38. Motion carried unanimously.

Burch moved Elder seconded for the approval of KDOT 2024 Leoti K-25 Pavement Restoration. Motion carried unanimously.

City Attorney Becky Faurot left the meeting at 7:00 pm.

City Superintendent Seaton reported that the city crew has been busy preparing for fall with mowing, weedeating, street sweeping. They finished patching up Carter Street and Bell Street where the water main breaks were located. Cunningham should be here next week to finish the water tower renovations.


