Mayor Cheryl Green and Councilors Kenneth Farr, Roger Porter, and Jim Roelfs were present. Also in attendance were City Attorney Becky Faurot, City Superintendent Tim Gutshall and City Clerk Ashley Woods. Councilors Amanda Baker and Matt Price were absent.

Mayor Green called the meetingto order at 7:00 p.m.

Roelfs moved, Porter seconded to approve the agenda with addition of item c. City Attorney to item VI. Reports and Item IX. Executive Session. Motion carried unanimously.

Mayor Green directed the public to the information on the agenda regarding addressing the council on agenda items.

City Clerk Woods had submitted written report to Council included in the packet. She also stated that W-2s had been mailed to all employees for 2016 on Demmber 28, 2016.

City Attorney Faurot talked about the annexation of K-96 stating that she was waiting on the legal description from the surveyor. She had sent her KOMA/KORA presentation materials to Wichita County Attorney Laura Lewis with the information that the City would like training extended and hadn't heard back yet. Lastly, she has been working with Deputy City Clerk Cendy Morcillo to help her with the transition to Municipal Court Clerk.

City Attorney Faurot went over the memo she prepared for the planning and zoning committee about recommendations for the fencing regulations.

City Clerk Woods went over the mail she had received from Gary Jordan regarding re-establishing a test well for City well #8 after the one he was responsible for via an agreement his company, Wright Lorenz Grain, had with KDHE, was closed in December 2015 by landowner Rick Gilmore without Mr. Jordan or KDHE's knowledge. They need to find a new test well site close to well #8; Council agreed to sounded like it was their issue and that if they had further questions to let us know.
