

**AN ORDINANCE**

**ALLOWING CONSUMPTION OF ALCOHOLIC LIQUOR WITHIN SPECIALLY DESIGNATED AREAS AT A SPECIFIC LOCATIONS  
AND TIMES DURING THE WICHITA COUNTY FAIR ON AUGUST 1-3, 2024.**

WHEREAS, K.S.A. 41-719(c) prohibits consumption of alcoholic liquor on public property;

WHEREAS, K.S.A. 41-719 (e) allows any county to exempt, by ordinance, from the provisions of subsection (c) specified property the title of which is vested in such county;

WHEREAS, K.S.A. 41-719(a)(2) allows alcoholic liquor to be consumed at a special event held on public streets, alleys, roads, sidewalks, or highways when a temporary permit has been issued pursuant to K.S.A. 41-1201; AND K.S.A. 41-1201 (e) allows cities to grant such a temporary permit by ordinance; and

WHEREAS, the Governing Body of the City of Leoti desires to promote special events to be held during the Wichita County Fair approved by the Wichita County Fair Board.

THEREFORE, BE IT ORDAINED, by the Governing Body of the City of Leoti, Kansas:


1. The request by Wichita County Fair Board for a concert/dance to be held in the fenced in area behind the Grandstands of the Wichita County Rodeo Arena on August 3, 2024, from 7:00 p.m. to 1:00 a.m. is hereby approved.
2. The request by Wichita County Fair Board for a designated drinking area held in a fenced in area on the east side and south side of the Wichita County Rodeo Arena, including the Rodeo Arena and pens on August 1-3, 2024, from 6:00 p.m. to 12:00 a.m. is hereby approved.
3. Pursuant to K.S.A. 41-1201(f)(1), a temporary permit for the consumption of alcoholic beverages is granted for the following public streets, alleys, roads, sidewalks, or highways: areas specially designated by the Wichita County Fair Board within the Wichita County Fairgrounds specifically for a concert/dance to be held in the fenced in area behind the Grandstands of the Wichita County Rodeo Arena on August 3, 2024, from 7:00 p.m. to 1:00 a.m. and for a designated drinking area on the east side and south side of the Wichita County Rodeo Arena, including the Rodeo Arena and pens on August 1-3, from 6:00 p.m. to 12:00 a.m.
4. The request by the Wichita County Fair Board for a designated drinking area for cooking for the Free Barbeque held in the fenced Show Arena on the north end of the livestock barn on August 1, 2024 from 3:00 p.m. to 8:00 p.m. is hereby approved.
5. Pursuant to K.S.A. 41-719(e) for a designated drinking area for cooking for the Free Barbeque held in the fenced Show Arena on the north end of the livestock barn is hereby exempted from the requirements of K.S.A. 41-719(d) from 3:00 pm to 8:00 pm, August 1, 2024. Thus during that time persons who may legally consume alcoholic beverages may do so on such public property for such limited time prescribed.
6. This Ordinance is conditional upon County exemption pursuant to K.S.A. 41-719(e)
7. Provided however, that any effected street, alley, road, sidewalk, or highway is to be closed to motor vehicle traffic by the governing body during such time.
8. The boundaries of the special event shall be clearly marked by signs identifying the area in which alcoholic liquor may be possessed or consumed at such special event.

9. No drinking will be allowed in vehicles not including pull type campers, livestock/horse trailers. Attendees shall abide by all laws of the city and state.
