

**AN ORDINANCE AMENDING SECTIONS 4-25, 4-67 OF THE CODE OF ORDINANCES FOR THE CITY OF LEOTI,
ALLOWING FOR EXPANDED HOURS AND DAYS OF ALCOHOLIC BEVERAGES RETAIL SALES AND CEREAL
MALT BEVERAGE RETAIL SALES**

WHEREAS, K.S.A. 41-2911 gives a municipality the authority to expand hours and days of sale at retail of both alcoholic beverages and cereal malt beverages.

WHEREAS, the Leoti City Council deems it in the best interests of the citizens of Leoti and Leoti businesses to do such.

THEREFORE, BE IT ORDAINED, by the governing body of the City of Leoti, Kansas as follows:

1. That Sections 4-25(3) of the Code of Ordinances, City of Leoti, Kansas, shall be amended to read as follows:

(3) Except as provided by subsection (4) of this section, no cereal malt beverages may be sold, dispensed, or consumed:

- a. On any day between the hours of 12:00 midnight and 6:00 a.m.*
- b. On Sunday, before 11:00 a.m. and after 8:00 p.m., except in a place of business which is licensed to sell cereal malt beverage for consumption on the licensed premises, which derives not less than 30 percent of its gross receipts from the sale of food for consumption on the licensed premises and which is located in a county where such sales on Sunday have been authorized by resolution of the board of county commissioners of the county or in a city where such sales on Sunday have been authorized by ordinance of the governing body of the city.*
- c. On Easter Sunday.*
- d. Closing hours for clubs and drinking establishments shall conform to K.S.A. 41-2614 and any amendments thereto.*

2. That Sections 4-67 of the Code of Ordinances, City of Leoti, Kansas, shall be amended to read as follows:

No retailer of alcoholic liquor shall sell at retail any alcoholic liquor:

- (1) On Sunday, before 11:00 a.m. and after 8:00 p.m.*
- (2) On Easter Sunday, Thanksgiving Day and Christmas Day.*
- (3) Before 9:00 a.m. or after 11:00 p.m. on any other day, Monday through Saturday, when the sale of alcoholic liquor is permitted.*


This Ordinance shall be published once per week for two consecutive weeks in the official City newspaper and shall be in full force after 60 days from the second publication.
